Statement of Fees – General information regarding your school fee account

- Your School Fee Invoice will be issued at the commencement of the school year in February 2018.
- The payment of fees is a responsibility agreed to at enrolment time and in fairness to all families' fees are to be paid.
- The School fees for 2018 have increased on average by 6% per student.
- **Tuition fees include** - compulsory excursions and activities.
- Classroom materials and resources for subjects via [Campion Education](#) Years 7-10.
- Information, communication and technology access at all levels.
- School diary & school year book.
- Year 12 Graduation Dinner/Mass (*1 ticket per Year 12 student*).
- **Sibling Discount** - 10% on Annual Tuition fees for the second sibling attending concurrently & 20% on Annual Tuition fees for subsequent sons attending concurrently.
- Administration charges may be applied where your account due deadlines have not been met. Collection charges, if incurred by the College, will be added to your account.

Items not included in your Tuition Fee

- Notebook • Years 11 & 12 textbooks, Years 7-10 English novels • School uniform • Private Music lessons • Stationery
- Optional overseas trips and excursions (*not a compulsory component of a student's 'course'*)

Capital Building Fund Program (Compulsory)

- \$500 per family per year (Please note this is not a tax deductible item)

Parents & Friends Contribution (Compulsory)

- \$30 per family - The funds raised are applied to desirable co-curricular purchases outside of the College budget, eg resources for student activities, music, sport etc
- This will be your only formal request for fundraising apart from Mission Action Day (Term 1).

Notebook Program - *The College policy regarding the purchase of notebooks for 2018 is spread over two years.*

- Students in Year 7 & Year 8 are on a notebook payment plan that is included with school fees.
- Students Years 9 continue to use their iPad.
- Students Year 10 & Year 11 are on a notebook payment plan that is included with school fees.
- New Students to Year 11 are on a notebook payment plan included that is included with school fees.
- **New students from St James College Yr11 will have \$750 added to 2018 Tuition Fees for their final instalment of Notebook.**
- Total cost of Notebook approximately \$1500 over a period of 2 / 3 years.

St Bede's College Terms of Payment - (For all terms and conditions relating to payment plans please visit our website)

- **Please note all fees must be finalized by 29 March 2018 if a College payment plan IS NOT in place.**

School Fee Payment Options – Please complete the enclosed form and return to Administration for processing.

- **Annually** - A lump sum payment of total fees is due by **29 March 2018** less your early payment discount of \$200 per student.
- **Monthly** – Eight monthly instalments commencing 15 March 2018 to 15 October 2018
- **Fortnightly** – Eighteen fortnightly instalments commencing 22 February 2018 to 18 October 2018

Families on an agreed Payment Plan in 2017 through St Bede's College

- Families that chose in 2017 to have their payment plan deducted by the College will automatically continue in **2018** with the same monthly or fortnightly plan.
- **If you do not want your payment plan to continue or you need to alter your details, please complete the enclosed Payment Options Form 2018 and return to the College by 19 February 2018. Please email to finance.admin@stbedes.catholic.edu.au or front administration.**

Students who Exit St Bede's College during the year

- Students who leave the College during the year are liable for the **full fees** up to and including the semester of the year in which their enrolment ends.

Difficulty

- To be eligible for financial assistance you must first complete a CSEF (Camps, Sports & Excursion Form) which is available, if you hold a valid means-tested concession card or are a temporary foster parent.
- You are required to provide a copy of your current Health Care Card or Centre link Pension Concession Card.
- Application forms are available on the College website through the parent portal.
- Families who encounter undue difficulty in making fee payments on time are urged to make contact with Mr. Dominic Langdon, Business Manager or Mr. Bryan Lobo College Accountant. Be assured that discussions on these matters is confidential.

Extra-Curricular Activities

VET (Vocation Education and Training) Fees

- The charge for the VET course is \$300.
- This will be invoiced with your school fees once information has been received.
- VET courses provide students with a range of alternative learning pathways.
- The courses are conducted by external course providers and the fees are in addition to those of St Bede's College. Parents please note VET course providers will invoice the College for their full school year fee and should you wish to withdraw your son from a course or leave the school after **March 29 2018 the full year's VET fee will remain payable by you.**

Outdoor Education

- Students who participate in this subject will be charged an extra fee:
- Year 10 Semester 1 \$250 Year 10 Semester 2 \$250 Units 1 & 2 \$700 Units 3 & 4 \$150

Instrumental Music

- Application forms are available to download from the College website.
- Private instrumental music tuition is available for all students in Years 7 to Years 12.
- An application form and payment is required prior to the commencement of the music lesson, which vary in charge depending on lesson and instrument needs.

- Individual Lessons per semester (per 15 lessons) \$480 • Shared Lessons per semester (per 15 lessons) \$307
- Year 8 - Junior Concert Band \$350 • Year 7 - Training Band per Year \$495
