School Fee Invoices will be issued at the commencement of the school year (February 2023). Administration charges may be applied where your account due deadlines have not been met. Collection charges, if incurred by the College, will be added to your account. **Sibling Discounts** are as follows; 10% on Annual Tuition fees for the second sibling attending concurrently, and 20% on Annual Tuition fees for subsequent children attending concurrently

### Included in Tuition Fees

- VCAL and Ungraded students are charged the full years' fee
- Classroom materials and resources for subjects Years 7 to 10
- School diary and school year book
- 1 x Student ticket to the Year 12 Graduation Dinner/Mass

### Not Included in Tuition Fees

- Notebook Program, Year 11 and 12 textbooks, Year 7 to 10 English novels; School uniform; Private Music lessons; Stationery
- Overseas trips and excursions (*optional - not a compulsory part of the curriculum*)

### Capital Building Fund Program (*Compulsory*)

\$500 per family, per year. *Please note this is not a tax deductible item.*

### Parents and Friends Contribution (*Compulsory*)

\$30 per family, which contributes to co-curricular purchases outside of the College budget, e.g. resources for student activities, music, sport etc.

### Notebook Program

- Students in Year 7 to Year 12 are on a Notebook Payment Plan that is included with school fees.
- Total cost of Notebook equates to approximately \$1,500 over a period of three years.
- If you should leave the College mid-year, you will be liable to pay the balance owing for the Notebook.

**Terms of Payment** (*available on our website*) Please note all fees must be finalised by 31 March 2023 if a College-approved payment plan is NOT in place.

### Payment Options

Annually - Lump sum (total fees, less early payment discount of \$250 per student) due 31 March 2023

Monthly - Eight monthly instalments, from 15 March 2023, to 16 October 2023

Fortnightly - Eighteen fortnightly instalments, from 23 February 2023 to 19 October 2023

## **EXTRA-CURRICULAR ACTIVITIES / ADDITIONAL FEES**

### **VET Fees**

The charge for a VET course is \$300, which will be invoiced with your school fees. VET courses are facilitated by external providers, therefore their fees are in addition to those of St Bede's College. Please note that VET course providers invoice the College for a full school year fee. Should you wish to withdraw your child from a course - or leave the school after 8 April 2023 - the full year's VET fee will remain payable. Similarly, if you should decide to join the VET program mid-year, full fees will be charged.

### **Outdoor Education**

Year 10 - \$250 per semester  
Year 11 Unit 1/2 - \$750  
Year 12 Unit 3/4 - \$150

### **Food Technology** (*Bentleigh East Campus Only*)

Year 9 - \$250 per semester

### **Instrumental Music**

Private instrumental music tuition is available for all students in Year 7 to Year 12. Payment is required prior to the commencement of the lessons, which vary in charge depending on lesson/instrument needs.

### **Private Chartered Bus Service** (*Bentleigh East Campus Only*)
